Submission Details:

The papers must be submitted ONLINE using single column format (maximum 10 pages) through Easy Chair link. Standard instructions for writing papers paper is 12 point times new roman with line spacings 1, A4 format. Running headings with 12 bold. First page will contain title and author information. The second page will contain title again and abstract and others contents of the paper. The submitted paper must be complete in all respects and must include results, figures, references etc. Review process will be double blind. PC will reject papers without review if the submission is not in proper format. Plagiarism of any form will lead to outright rejection of the paper.

- At least two independent reviewers will review and approve a paper
- A maximum of 10 papers will be assigned to a single reviewer
- All the review reports to be send to the respective authors

- Easy Chair weighted score to be used for making list of accepted papers.
